#### GENERAL TERMS AND CONDITIONS

1. TFFM Radio reserves the right to:

1. Refuse at its discretion to accept any advertising material that is the opinion of TFFM Radio as not consistent with guidelines or does not meet the technical linguistic or quality standards as determined by TFFM Radio.
2. Change the rates, terms and conditions at any time;
3. Cancel, reschedule or replace any TFFM Radio program or advertising break;
4. Reschedule advertising booking at any time.

2. If an advertising booking is made in connection with a particular TFFM Program and that particular program is cancelled, the advertiser may have the booking rescheduled to a mutually acceptable time or cancel the booking without charge.

3. For booking cancellations made within 30 days of the first day of Broadcast, or production cancellations made within 24 hours of the TFFM Radio recording session, TFFM Radio will be entitled to payment as if the advertising had been broadcasted or the production had taken place in accordance with the original booking.

4. TFFM Radio gives no guarantee about the proximity of commercials advertising rival products unless 4 weeks notice in writing is received and accepted in writing by TFFM Radio.

5. TFFM Radio advertising time may not be resold or sublicensed.

6. The advertiser indemnifies TFFM Radio against any costs, expenses and damages which TFFM Radio may incur arising out of a commercial or sponsored program provided by the advertiser or the agency of the advertiser, the agency indemnifies TFFM Radio against any costs, expenses and damages which TFFM Radio may incur arising out of the broadcast.

7. All advertising bookings must be paid in full before the first date of the broadcast unless credit term has been previously agreed with TFFM Radio. TFFM Radio retains the right to refuse to extend credit to any client.

8. TFFM Radio will not be responsible for archiving any advertising material for more than one year after the first date of the broadcast.

9. TFFM Radio contract with media advertising agencies and media buying agencies in their own right and not as agents of their clients.

10. Rates quoted are inclusive of all taxes and GST.

11. This agreement shall commence on signature date and shall continue unless terminated by either party with 30 days notice in writing.
